

**POWER PLAY SPORTSCARDS: AGREEMENT TO ADHER TO THE BOULEVARD  
SPORTSCARDS & MEMORABILIA SHOWS RULES AND REGULATIONS ("Agreement")**

The following rules and regulations have been adopted by the Boulevard, their affiliates, officers, directors, agents, employees, shareholders, and assigns (the "Venue") to ensure the maximum safety and enjoyment of all involved. In consideration for participation in the Sports Cards & Memorabilia Show (the "Show") being administered by Power Play Sportscards, their affiliates, officers, directors, agents, employees, shareholders, and assigns ("Power Play") at the Boulevard located in Las Vegas, Nevada (the "Show Location" or "Premises") for the time period listed below, I, my affiliates, officers, directors, agents, employees, shareholders, and assigns ("Dealer" or "Dealers") do hereby agree to abide by the following rules and regulations:

1. Dealers that have paid table fees will be the only entity permitted to setup on the Premises. Dealers must check in prior to unloading. Dealers will not be given any table location information on the day of the show until all fees have been paid and the sales tax form signed. Dealers must comply with all Nevada sales tax and license laws. Any dealer that does not comply with the sales tax and license laws will be barred from future shows. No subletting of table space is permitted.
2. **A 50% deposit of table fees owed is required to hold a reservation. NO RESERVATIONS WILL BE CONFIRMED UNTIL SUCH TIME AS A CONTRACT HAS BEEN COMPLETED AND SIGNED AND A DEPOSIT HAS BEEN PAID.** A signed contract does not guarantee your space. If your contract is received after the show is Sold Out, your deposit will be returned to you and your contract will be considered invalid.
3. In the event Dealer cancels a reservation, written notification must be received by Power Play no less than **20 calendar days** prior to the Show. **No phone cancellations will be accepted.** Dealer may provide written notice by e-mail to [shows@powerplaysportscards.com](mailto:shows@powerplaysportscards.com), or by mail addressed to: Power Play Sportscards, Attn: Table Cancellation, 5546 Camino Al Norte, #2-305, North Las Vegas, NV 89031-0805. **NO REFUNDS OR CREDIT WILL BE GIVEN FOR ANY RESERVATION CANCELLATION IF IT IS RECEIVED BY POWER PLAY SPORTSCARDS LESS THAN 20 CALENDAR DAYS PRIOR TO THE ABOVE EVENT. DEALER WILL BE LIABLE FOR AND OBLIGATED TO PAY THE FULL TABLE FEE OWED.**
4. Dealers must adhere to all fire codes and city building codes. All electrical equipment must be UL approved. Cords must be covered with skid-proof mats or carpeting and/or taped to the floor using brown vinyl tape in all walkways and must be approved by Power Play in advance.
5. Dealer will abide by all Federal and State laws regarding the sale of unlicensed items and the running of games of chance. Power Play and Boulevard are not responsible for any exhibitor's unlawful actions and procedures during the show.
6. Power Play and the Venue indemnify themselves against any unforeseen incidents or acts of God that may cause the show to be postponed or canceled.
7. Dealers are not allowed to solicit or petition Venue customers for any purpose other than the purpose intended for the Show.
8. All set-up and breakdown must be done when the venue is closed. Venue hours are: Monday through Saturday, 10:00 a.m. to 9:00 p.m.; and Sunday, 11:00 a.m. – 7:00 p.m. Displays must be manned and open by the Dealer during all operating hours of the Venue. All displays must be removed from the venue immediately following venue hours on the final day of the event. Any components not removed as specified above become venue property and will be disposed of as deemed appropriate by the Venue. **(Mall hours are subject to change)**
9. Dealer is responsible for keeping the area around and under their table(s) neat and clean at all times. Any items not on display must be concealed under tables. Trash, boxes, etc. shall be disposed of in dumpsites located at the loading docks, not in Venue trash receptacles or hallways. Dealer will not move or displace any seating or planters. Any damage to the property is the direct responsibility of the Dealer.
10. All signs must be professional. Handwritten signs are not permitted. No signs, merchandise, or decorations may be displayed on or adhered to any structure. No display may be more than 6' high without approval from Power Play and the Venue. Helium balloons are prohibited.
11. Use of any and all sound emitting devices (television, stereo, public address, musical instruments, etc.) must be approved by Power Play and the Venue. Volume must be kept at a level so as not to interfere with business, and must be adjusted accordingly if requested by Power Play or the Venue.
12. Power Play and the Venue reserves the right to: 1) remove any organization from the Venue who has not conformed to the above rules and regulations; 2) remove any organization whose display or event is not in good taste as deemed by the Venue; and 3) to refuse service to anyone.

**WAIVER AND RELEASE OF LIABILITY**

1. indemnify and hold Power Play and Boulevard, its owners, affiliates, officers, directors, shareholders, assigns, agents, members, partners, associates, contractors, servants, and employees (the "Venue"), harmless from and against any and all claims for personal injuries, death, damages, costs, and/or other expenses, including reasonable attorney's fees, arising from or part of facility thereof by the Dealer; and
2. release, discharge and acquit the owners of the real estate, the successor and assigns, their Lessee, the Venue Management Company and Venue Tenants from any and all claims, demands and actions for any loss, costs, expenses, damage or injury either to the person or property of the Dealer and each member of the Dealer sustained by reason of any condition of Show Location, or due to any act, except resulting from gross negligence or willful misconduct or any employee or agent of the Venue, Power Play, the Venue Tenants, or the act of any other third person all of which claims are hereby waived by Dealer for itself and each of its members.

I further agree, on behalf of myself, and on behalf of my affiliates, officers, directors, shareholders, assigns, agents, members, partners, associates, contractors, servants, and employees, to abide by all the rules and regulations as hereinafter amended or supplemented, established by Power Play and Venue or anyone designated by Power Play or the Venue. I hereby represent that I am duly authorized by the above name dealer/company to sign this Agreement.
